



# BILL TO ADOPT AMENDMENTS TO THE S.G.A. BYLA S

## ARTICLE

- Section C. All elected or appointed positions shall be organized by the S.G.A., with the exception of R.C.A. positions (excluding the R.C.A. president). Executive and Senator positions shall be elected in the spring semester. All other positions will be elected or appointed according to their respective operating principles.
- Section D. All candidates must without except on meet the requirements for the office of their candidacy as declared in the constitution and by-laws.
- Section E. No member of S.G.A. shall be allowed to serve in two const tutional branches, other than the of cers so required by the constitution. Further, no candidates shall appear on the S.G.A. ballot more than once. Nor, shall any

  - 4. Record the minutes of each Senate meeting, C.A.B. and Execut ve Council meeting.

- 6. Perform all other functions, as defined in the Residential College Association operating principles.
- 7. Perform any additional tasks, as assigned by the President.

## Section B. Senators

#### The Senators of the Student Senate shall:

- Maintain at least a 2.0 G.P.A. on a 4.0 scale at the time of election and during the term of office.
- Support the mission, goals and objectives set forth by the Student Government Association.
- Accept additional roles and responsibilities in certain projects and programs later agreed upon.
- 4. Attend all weekly Senate meetings and committee meetings
- Coordinate and conduct Campus Outreach Project (C.O.R.P.)
  tables, in a location that is frequented by the specific constituents
  of each Senator.
- 6. Serve on a minimum of one University committee as needed
- 7. Serve on a minimum of one Senate committee.
- Serve a minimum of one hour a week in the Student Government Association office.
- Maintain proper contact with the organizations that they are
  assigned to in order to promote a positive exchange of ideas
  between representatives and constituents as determined by the
  Executive council.
- 10. Perform any addit onal tasks, as assigned by the President.
- 2. The Senators elected from the individual University Colleges/Schools shall:
  - Maintain a major in the college they represent
- The Senators elected from the individual Residential Colleges shall:
  - 1 Maintain Lesideney affiliation in that specific Residential College
  - 2. At end and report the actions of the S.G.A. to their specific Residential College Council
